1. OBJECTIVE

1.1 The objective of this document is to define the policy for IIUM network services provided by the University.

2. TERMS AND DEFINITIONS

Term	Definition
IIUM	The International Islamic University Malaysia, otherwise known as the “University”.
ICT	Information and Communication Technology.
ITD	Information Technology Division.
ITD Management	CIO, Director, Deputy Directors and Team Leaders.
Staff	Permanent Staff and Contract Staff of IIUM.
External party	Guest or visitors.
Network-connected	All devices that are connected by wire, optical cables, or wireless to the digital telecommunication networks that are owned and/or operated by the University.

3. POLICY STATEMENTS

3.1. General

3.1.1 All staff and matriculated students of IIUM are entitled to have access to the University’s network.

3.1.2 External party of the University shall be given the network access via wireless connection with restricted usage time.

3.1.3 Request for network services apart from clauses 3.1.1 and 3.1.2 shall be forwarded to ITD Director for approval with the recommendation from Deans and Directors at Centre of Studies and Administrative Offices.

3.1.4 Users are responsible for any activity on his/her network account.

3.1.5 The University reserves the right to revoke the network connections whenever deem necessary.

4. IMPLEMENTATION AND NON-COMPLIANCE

4.1 The Director of Information Technology Division holds the responsibility for the implementation of this policy and shall take necessary actions in the event of violation of this policy.

4.2 This policy is applicable to all users of the University's network services and any infringement of the policy may subject to disciplinary actions and any other actions deem's necessary.

5. ENFORCEMENT

5.1 This policy is applicable to all staff, students and external party of the University and any infringement of the policy may subject to disciplinary actions.
