AMENDMENTS TO THE IIUM POLICY AND PROCEDURE ON ACADEMIC INTEGRITY AND HONESTY 2008

May this email reach you in the best of health and *Iman* with the Grace of Allah swt.

2. Kindly take notice that Senate in its meeting no 426 on 24th June 2016 has approved and endorsed the amendments to the IIUM Policy and Procedure on Academic Integrity and Honesty 2008. The amendments are as follows:

2.1 Under PART IV: Procedures for Dealing with Breach of Academic Integrity and Honesty, at Paragraph 5 under the heading of 'Improper Research Practices', Two (2) new sub-paragraphs are inserted after sub-paragraph 5(iii) namely;

(iv) Submitting an article to two or more journals at the same time with an expectation that at least one of the journals will publish the article;

(v) Submitting a research proposal to two or more grant providers with an expectation that at least one of the grant providers will approve and award the grant for the research;

2.2 A new Paragraph 40 on Academic Misconduct in Thesis and Dissertation is inserted.

40. When there is an allegation of academic misconduct in thesis or dissertation, the DEC/MEC committee's proceeding shall be postponed and the matter shall be forwarded to the relevant Centre of Studies to be investigated. Upon completion of the investigation, the Centre of Studies shall send the said report to the Office of Deputy Rector (Academic Planning) to be tabled at the Academic Integrity Committee to be chaired by the Deputy Rector (Academic Planning). The Committee of Academic Integrity shall make a decision as to the status of the thesis or dissertation. The decision shall be communicated in writing to the DEC/MEC. The procedures of inquiry shall be the existing policy to be followed *mutatis mutandi*.
