1.0 The Senate was presented with the following:

A proposal to amend the Postgraduate Policy (Revised 2015) for Application for Change of Programme / Specialisation between and within Centres of Studies (CoS).

1.1 The SAC 01/G161 has agreed to enforce the rule of Change of Programme within CoS (Clause 13.2) effective immediately. In order to strengthen the process and to guide all CoS on this new process, the CPS has prepared the SOP and detailed process.

1.2 The SAC 06/2017 held on 26th July 2017 also recommended to make amendments to clause 13.1 to include the following sentence:

13.1(a) "The CoS may recommend applications from year two (2) students due to special circumstances".

13.1(b) Students applying for Change of Programme from an executive programme to a main stream programme must fulfil the entry requirements.

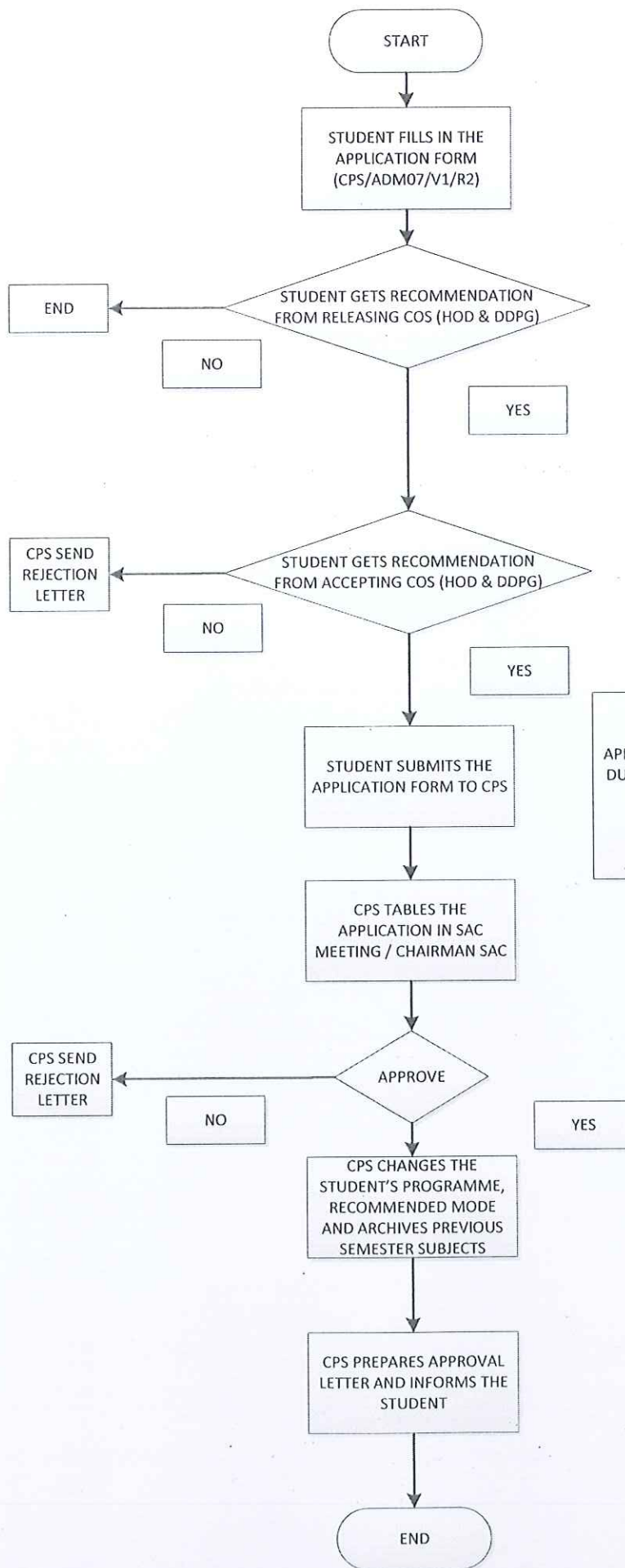
1.0 The Senate was presented with the following:

1.1 The revised programme structure is proposed to be implemented in Semester 1, 2017/2018 (Batch G171 onwards) by the departments.

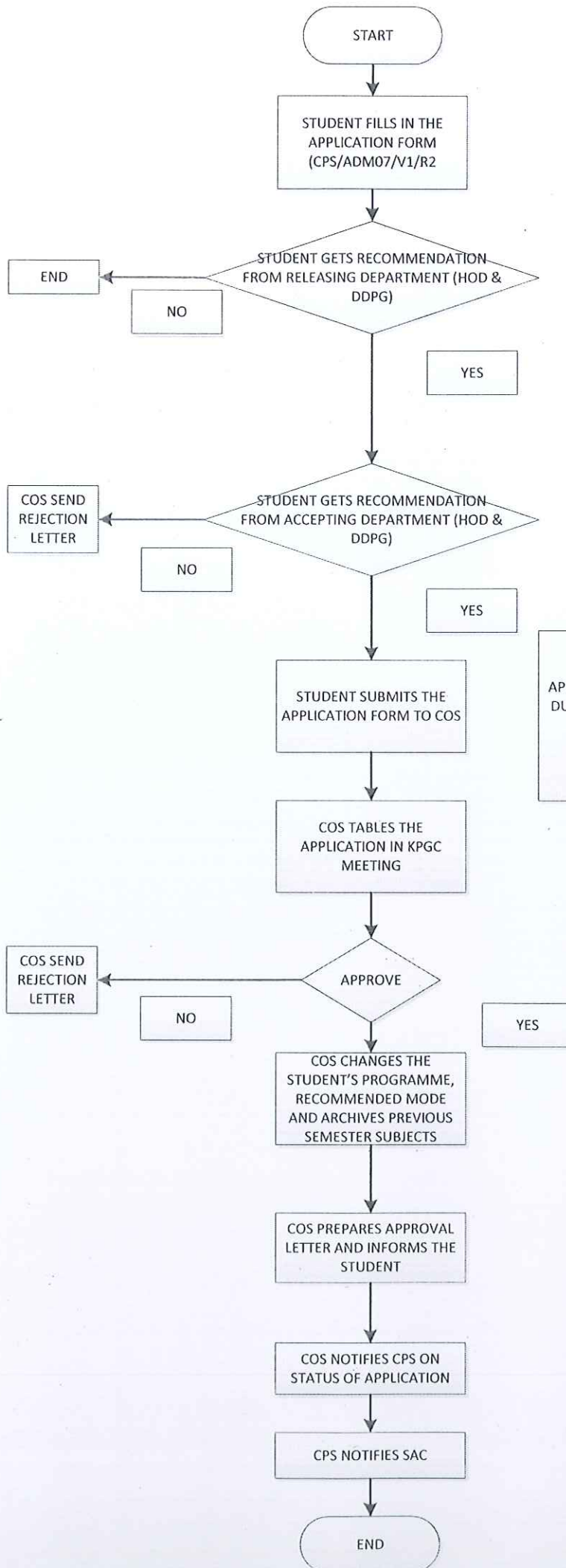
