



**IIUM OFFICIAL GUIDELINES FOR STUDENTS OPS PULANG IPT  
DURING THE MOVEMENT CONTROL ORDER (MCO) 06/2020**

*\*This guideline is applicable for students **returning home by own vehicle, Gerak Malaysia and fetch by parents** as per directive by the Malaysian Government*

**SECTION 1: BACKGROUND**

1. The period of MCO (18<sup>th</sup> March to 12<sup>th</sup> May 2020) aims to overcome the spread of COVID-19.
2. IIUM is committed in ensuring the safety of the staff and students. Therefore, the University takes all instructions by the Government seriously.
3. Students who are on any of the IIUM campuses are not allowed to leave during the MCO period UNLESS deemed necessary, and subject to current directives by the relevant authorities.
4. As per directive by MOHE on 24<sup>th</sup> April 2020, students from Selangor, Kuala Lumpur and Putrajaya who are still on campus are allowed to return home by their own vehicles.
5. Students from Selangor, Kuala Lumpur and Putrajaya who are still on campus may also be fetched by parents to return home.
6. Students may also return home under the Gerak Malaysia 2.0 initiative by the Government.

## **SECTION 2: SOP FOR STUDENTS RETURNING HOME BY OWN VEHICLE**

1. Students must fill up application form at <https://bit.ly/2W9KsOH>.
2. STADD will issue movement authorisation letter to students.
3. Students without movement authorisation letter from STADD will not be allowed to leave the campus. Students must furnish the letter to OSEM at IIUM main gate when departing.
4. Students must notify Mahallah Principals of their departures to home.
5. Students departing by own vehicles can do so beginning 7<sup>th</sup> May 2020. However, they are restricted to Green Zones destinations within Selangor, Kuala Lumpur and Putrajaya only.

## **SECTION 3: SOP FOR STUDENTS RETURNING TO HOME WITH PARENTS**

1. Students must fill up application form at <https://bit.ly/2W9KsOH>.
2. STADD will issue movement authorisation letter to students.
3. Students without movement authorisation letter from STADD will not be allowed to leave the campus. Students must furnish the letter to OSEM at IIUM main gate when departing.
4. Parents will be allowed to fetch students at the IIUM main gate only. Parents will not be allowed to enter campus.
6. Students must notify Mahallah Principals of their departures to home.
7. Students departing with parents can do so beginning 7<sup>th</sup> May 2020. However, they are restricted to Green Zones destinations within Selangor, Kuala Lumpur and Putrajaya only.
8. Parents from Green Zones outside Selangor, Kuala Lumpur and Putrajaya must request travel permission from nearest police station.

#### **SECTION 4: SOP FOR STUDENTS RETURNING HOME UNDER GERAK MALAYSIA**

1. Students must fill up application form at <https://bit.ly/2W9KsOH>.
2. Students departing under Gerak Malaysia can only do so on 7<sup>th</sup> – 10<sup>th</sup> May 2020.
3. Students will have to show proof that they are allowed to return home under Gerak Malaysia at OSEM at IIUM main gate. Otherwise, they will not be allowed to leave the campus.

#### **SECTION 5: OTHER MATTERS**

1. Students are advised to bring home materials (including personal computers and study notes) needed for online learning.
2. Students must practice physical distancing, wear face mask and use hand sanitiser/wash hands accordingly throughout the journey.
3. Students must observe the rules and regulations of the receiving State authorities.
4. **Students will not be allowed to return to campus before Semester 2, 2019/2020 is officially resumed.**
