



IIUM OFFICIAL GUIDELINE FOR STUDENTS' ACTIVITIES DUE TO THE CONDITIONAL MOVEMENT CONTROL ORDER (CMCO) 02/2021

*This guideline is applicable for IIUM Gombak and Pagoh campuses only

SECTION 1: BACKGROUND

1. The COVID-19 outbreak has affected all students' activities in IIUM.
2. IIUM is committed in ensuring the safety of the students. Therefore, the University adheres to all the instructions by the Government seriously.
3. The government has begun to loosen the strict rules in many areas, however, the University believes that in the continuous fight against COVID-19, success is much dependent on everyone's responsible behaviour, and being honest in ensuring the safety of oneself and others.
4. Therefore, this guideline is developed to determine the students' activities on and off campus throughout the Conditional Movement Control Order.
5. This guideline is subject to change from time to time following announcements from the relevant authorities.

SECTION 2: ORGANISING AND PARTICIPATING IN STUDENT ACTIVITIES

1. Students are required to activate *MySejahtera* application at all times.
2. Activities through online programmes are very much encouraged. Example of such activities are e-tournament, e-sports, online book review, online forum, trainings, et cetera.
3. Any student activity outside of IIUM Campuses **is allowed** upon recommendation by the IIUM Approving Authorities and approval by the Deputy Rector (Student Development and Community Engagement).
4. All activities conducted outside of IIUM campuses **must** be located within the green zone. (please refer to Ministry of Health's website for the current status).
5. Any student activity on and off campus must comply with the following :
 - a. An allowance of 50% of the capacity is allowed depending on the size of the venue ; (for example, a venue that can accommodate a maximum of 1000 people, only 500 will be allowed to attend) ;
 - b. To practice physical distancing of 1 meter apart at all times ;
 - c. The venue must be an open and ventilated area with different entrance and exit ways ;

- d. Organisers, coordinators, speakers and participants must undergo body temperature screening (a maximum of 37.4°C) ;
 - e. The organiser must provide complete details of the participants (name, matric number, active contact number, active email address) ;
 - f. The organiser must ensure all participants wear face mask at all times ;
 - g. The organiser must provide hand sanitizer ;
 - h. Advisor/Officer-In-Charge must be present throughout the programme ;
 - i. The organizer must ensure that none of the persons involve in the programme has been in close contact to a COVID-19 positive case, person under surveillance (PUS), person under investigation (PUI), probable case of COVID-19 or actively on surveillance of COVID-19 risk ; and
 - j. Symptomatic organizers, coordinators, speakers and participants are **not allowed** to enter the venue during the activities until they have received the clearance from IIUM Health and Wellness Centre (IHWC).
6. For invitational programmes off-campus, the organiser is required to provide a written assurance of practicing SOPs.
 7. In instances where physical distancing cannot be avoided or physical support is required, such as assisting students or staff with disabilities, the person assisting must wear a mask and gloves, and wash his/her hands frequently.
 8. These steps must be followed strictly when conducting the programmes/activities.

SECTION 3 : CONCLUSION

1. Students are to adhere to all the safety measures and regulations by the University authority.
2. This advice is for the best interest of public health and safety.
3. Let us take this COVID-19 pandemic as an opportunity to reinstate the renewed norm.
4. This guidelines is applicable until further notice.
5. Failure to adhere to the SOPs will result in revoking the permission of conducting any physical activities.
